(A) denotes a National Accredited Judge who has been certified by National Garden Clubs, Inc. after taking and passing Courses I through IV of Flower Show School, fulfilling judging and exhibiting requirements, and passing the *NGC Handbook* exam.

(L) denotes a National Accredited Life Judge. To obtain a Life Certificate, a judge must renew the certificate three times. Two refresher courses must be Symposiums, the third may be a Symposium or FSS Course III or IV. An Accredited Life Judge working towards Accredited Master status must successfully complete two Symposiums for credit.

(M) denotes a National Accredited Master Judge. To become a Master Judge, the judge must hold a Life Certificate and successfully complete two Symposiums (see *HB* for complete details). To remain in good standing, ALL Accredited Judges must successfully complete a Symposium every three years. Master Judges must audit a Symposium and fulfill exhibiting requirements.

(S) denotes a Student Judge who has completed three courses of Flower Show School.

(SE) denotes a Student Exhibitor who has completed two courses of Flower Show School.

Horticulture Judges are certified by the FGCNYS, Inc.

(M) denotes a Merit Judge who has taken three refresher courses of Horticulture School.
